When contacting interpreters from our website, please mention that you obtained their details from the National Register.

### NHS commences procurement for language services

NHS Shared Business Services Limited (NHS SBS) has commenced a <u>procurement</u> for the provision of interpreting and translation services, with the deadline for submissions of Friday 12 August 2016 at 12:00. The framework requires contractors to access the NRPSI register for spoken-language interpreters and for the interpreters used to be DPSI qualified or NRPSI registered.

# Interpreters working with the police

Based on feedback that we are receiving, there seems to be some confusion about the role of interpreters in police interviews. The NRPSI's position is that the interpreter should assist the Police Officer in taking a statement: the interpreter should <u>not</u> take the statement themselves. Different forces take different approaches to taking statements – the College of Policing <u>Authorised Professional Practice</u> (pp 233-234) details two options. Whichever approach is taken, however, it is clear that the interpreter should never be left alone with the interviewee or expected to take the statement, as this could affect their impartiality and conflict with the NRPSI Code of Conduct.

#### **House of Lords debate**

The House of Lords debated the subject of <u>'Courts: Resourcing and Staffing'</u> on 14 July 2016. Baroness Coussins', Co-Chair of The All-Party Parliamentary Group on Modern Languages (APPG), requested assurances that the Brexit negotiations will ensure there is no diminution in the right to interpretation in the criminal justice system. She also specifically addressed the problems, as freelancers, that interpreters face in obtaining security clearance and suggested, as recommended by the NRPSI, that the Rehabilitation of Offenders Act 1974 (Exceptions) Order 1975 be amended to include "interpreting in the public services" in the excepted professions.

#### **Bookmarking interpreters**

There is a very useful facility for logged in users to bookmark Registered Interpreters who they use on a regular basis. Simply identify the interpreter after doing a search, and click on the open book icon against the Registrant's record. You can then go straight to your bookmarked interpreters in the 'My Account' section.
